4. The material facts constituting probable cause that the search should be made are:

On Monday, May 17, 2021 members of the Chesapeake Police Department responded to an abduction and homicide of Laura Miles. She was believed to be abducted from her apartment building's parking lot located at 3500 Clover Rd. in the city of Chesapeake, VA. Mrs. Miles was located deceased with several stab wounds in the wooded area behind 4626 Taylor Rd. in Chesapeake, Virginia. Her 2020 Ford F-150 bearing New York tag GSB-3459 was located near the intersection of Bangor Dr. and Meadows Way. Her cell Samsung cell phone and vehicle keys were not recovered. The vehicle was processed for forensic evidence. On Saturday, May 22, 2021 the finger prints of Raheem Cherry were located on that vehicle. I, Det. Coleman had previously viewed a video of a suspicious male wearing a plaid shirt and camouflage head cover and black slide on shoes enter the breezeway of the apartments of Sawgrass Ln approximately 20 minutes prior to the abduction and homicide. That male had a cell phone in his hand and walked around the parking lot. This apartment is only a few hundred feet from where Mrs. Miles was abducted. On Saturday, May 22nd, 2021 Det. Lightfoot and Det. Hatchell made contact with Mr. Cherry by phone and responded to 3305 Pampus Ln. apartment 302 in reference to conducting an interview with him. Both detectives saw him exit that apartment. Mr. Cherry advised that he has been staying at that apartment with his girlfriend for the past few weeks.

I, Det. Coleman compared the male in the video with mug shots of Raheem Cherry and they appear to be the same individual. I am seeking a DNA sample from Raheem Cherry by way of buccal swap for comparison with DNA recovered from the scene.
