On November 9, 2021 at 1734 hrs. Portsmouth Police Emergency Dispatch received several 911 calls about gunshots fired in the 2100 block of Pearl St., Minutes later dispatch upgraded the call to a gunshot wound. According to a caller/witness who resides inside of the location. They stated that a female had been shot inside the residence located at 2118 Pearl St. and that the victim possibly knew the shooter.

Police responded to the location Police tried to make entry into the front door, three bullet holes were observed in the front door with an inward projection and three spent 9mm shell casings were found on the porch and front yard. Officers were not able to make entry to the front door, so they went around to the back door and encountered an individual trying to exit through a bedroom window. It was later ascertained that this was the caller/witness. At the time, they were trying to escape the residence with the victim's One year old daughter in their arms.

Officers made entry into the residence and located a female victim who was Identified as 27-year-old Auriel McLaurin who was lying on the floor in front of the front door with gunshot wounds to the upper torso. Medics arrived on scene pronounced the victim deceased at 1751 hrs.

The caller/witness was interviewed. During the investigation, it was found that McLaurin was disputing with a male friend named "Ryan". According to the caller/Witness, they stated that the altercation became heated. "Ryan" had a ride on the way and attempted to leave and according to the caller/witness, McLaurin attempted to stop him. When "Ryan" persisted that he leaves, McLaurin told him to remove any and all clothing that she purchased for him. "Ryan complied and removed his jacket and shoes. At some point, the argument became physical. According to the caller/witness, they then took McLaurin's one-year-old daughter and went to feed them. They then stated that McLaurin and "Ryan" continued to fight until they heard the front door close and lock. The caller/witness stated that they then heard three gunshots and when they looked outside, they saw a black vehicle leaving the scene at a high rate of speed.

Police located Ryan's clothing and shoes in the laundry room. There were signs of struggle visible in the residence. Police received an anonymous call from someone who stated that "Ryan's" full name was Ryan Winfield 27-year-old B/M. Police later recovered a VA Identification Card belonging to Winfield as well as a 9mm S&W gun

magazine which was located inside of a fanny pack underneath the victim.
