On June 7, 2022, I made contact with Ms. [REDACTED] via phone call in reference to reporting an unlawful filming incident that occurred at Lakeview Medical Center, 2000 Meade Parkway.

Ms. [REDACTED] advised that she is a Nurse Practitioner in the Endocrinology department of the building, and today (06/07/2022) marked her last day working for Bayview. Ms. [REDACTED] advised that between the hours of 14:30 and 14:40 she was standing at the charting station typing when she felt a sensation by her feet resembling an item being dropped. Ms. [REDACTED] subsequently felt a brief tap on her foot. Ms. [REDACTED] proceeded to step back, and look down to find a cellphone on the ground that was positioned directly between where her feet had been. She noted that the phone was screen side down, and the camera lens was facing upward. Ms. [REDACTED] added that just prior to this, she noticed that Dr. Giovanni Geronilla, from the Family Medicine department, had been standing uncomfortably close to her. Ms. [REDACTED] observed Dr. Geronilla pick up the phone, and inquired if it belonged to him where he responded yes. Ms. [REDACTED] believed Dr. Geronilla was recording her from underneath her dress as she has knowledge of him being reported doing this in the past in another state. Ms. [REDACTED] advised she was wearing a leopard print, knee-length dress with a black thong and no panty hose underneath.

I then made contact with a witness, Mr. [REDACTED], who advised that he observed Dr. Geronilla standing uncomfortably close behind Ms. [REDACTED]; while she was charting. He then observed Dr. Geronilla drop the phone from a low level, and noted that camera lens was facing upward. Mr. [REDACTED] then observed Dr. Geronilla slide the phone further under Ms. [REDACTED] using his right foot. From there, Mr. [REDACTED] observed Ms. [REDACTED] step back from Dr. Geronilla as he retrieved the cellphone. Mr. [REDACTED] could not advise the status of the screen to articulate whether it was recording or not.

I made contact with an additional witness, Ms. [REDACTED], who advised that she had just completed triage with a patient, and as she entered the clinic she observed Dr. Geronilla picking up his cellphone from where Ms. [REDACTED]' feet were. Ms. [REDACTED] I noted that the camera lens faced upward, and that she observed the screen viewed camera mode actively recording due to the red button observed on the camera mode.

I made contact with a final witness, Ms. [REDACTED], who advised that she had just observed Dr. Geronilla was in the process of picking up his cellphone from the floor by Ms. [REDACTED] feet. She noted that the camera lens was facing upward, and when Dr. Geronilla held the phone up to his face, as if he were answering the phone, she observed the screen viewed the phone to be in camera mode.

Phone was described to be an iPhone with a blue case and credit card hold attached to the back of the phone. Dr. Geronilla was not known to frequent the Endocrinology department per all the witnessing parties, and the parties involved found it unusual that he was "hovering" Ms. [REDACTED] on this date.

During the investigation, Dr. Geronilla was identified as Giovanni Genevoo Geronilla born on July 28, 1978 with a last known address residing ~~at~~ in Norfolk, VA.
