

Just following up on this Blanchard case. Does he still have court on October 11? I didnt receive a subpoena for it and dont know if i'll be able to make it or not.





Ms. Davenport:

Thanks in large measure to the attention this case has received on social media, CCPD Special Victims Detectives received a tip last week, which led to the execution of a search warrant and the seizing of a video germane to our case against Pastor John Blanchard.

While this new information doesn't change a single word uttered or activities undertaken by anyone on the day of our investigation, it incontrovertibly validates our assertions that Blanchard knowingly sought to engage in sex with an underage girl in a Chesterfield County hotel room on the day of his arrest. Since children cannot rent hotel rooms, it is reasonable to conclude that Blanchard was, at minimum, indifferent to the reality that the person with whom he had been texting was not a prostitute but rather a child victim of human sex trafficking. A felony.

Please review the video and supplemental report (the video should be on its way to your office this morning). In light of this validation, I ask that you reevaluate your stance on setting aside the felony charge we submitted - as well as your consent to seal all records associated with this investigation.

If you feel this case has become too controversial for your office to pursue ethically, I respectfully request you consider the intervention of a special prosecutor to represent the interests of the Commonwealth.

As always, I appreciate your consideration and expertise in this matter and hope you'll continue to partner with us in our efforts to protect the vulnerable in our community. Any questions or desire to discuss further, please let me know.

The attorney from the CA's office handling the case was Alex Michev. Blanchard's lawyer had apparently reached out to Stacey who spoke with Alex about how the case should be handled. Blanchard, like all the defendants, was charged with the felony offense pertaining to soliciting an underage prostitute. As I recall, when I spoke to Alex after we found out the case was to be nolle prossed, Alex Michev advised that the issue was that Blanchard had a "built in defense" because he did not acknowledge the age, and that he claimed he was driving and didn't see the text where the UC says she's 17.

As to why the case wasn't sufficient to move forward via reducing the charge to a misdemeanor (just regular solicitation of a prostitute) like several of the others proceeded......he advised that they felt we wouldn't get anything out of a misdemeanor conviction, and the better outcome was that Blanchard receive the sex offender counseling which contained components of a psychosexual evaluation. This was reiterated by Ms. Nesbitt in the meeting we all had in October where we essentially agreed to disagree on that point.

As far as the Blanchard case is concerned, to my understanding that is the only feedback we received. is out in the field helping with following up on the allegations made by the missing juvenile we found last night. If you'd like, when she's back I will double check with her and a couple of others who were directly involved with the case to see if they got anything additional from the CAs.


