Your failure to pay or respond to this Notice of Violation as directed will result in the matter being submitted to the City of Suffolk Treasurer's Office for collections proceedings.

TO PAY YOUR VIOLATION

THERE ARE THREE WAYS TO PAY:

- 1. ONLINE PAYMENT: The fastest and easiest way to pay your Summons is to pay online. Go to www.onlinecitationpayment.com and log on with your Summons and PIN shown on the front of this notice. Click the Pay button. There may be a convenience / service fee for this service.
- 2. PAYMENT BY PHONE: Call (866) 271-1171, 8 AM 5 PM EST Monday Friday. There may be a convenience / service fee for this service.
- 3. PAYMENT BY MAIL: Mail your check or money order (payable to the City of Suffolk) with the coupon printed at the bottom of the front side of this notice. DO NOT MAIL CASH. Be sure to put the Summons # (see front) on the face of your payment.

If you pre-pay, you **DO NOT** need to appear in court.

TO CONTEST THIS VIOLATION

- 1. COURT HEARING: If you wish to contest this violation in court, you must sign the coupon below and mail it in the enclosed envelope to: City of Suffolk, PO Box 17007 Baltimore, MD 21297-0496 to confirm your court hearing. Your case will be administratively reviewed and you will be notified, in writing, of the location, date and time of your court hearing. A person who is found liable for a violation after the court hearing shall pay the penalty within 30 days of the determination of liability.
- 2. AFFIDAVIT OF NON-LIABILITY: If the motor vehicle or the license plate captured by the Automated Traffic Control System recorded image was sold or stolen prior to the violation date, or if there is a DMV registration error, or if the offense was ticketed by the Police Department, or you were not the operator/driver of the vehicle on that date, time and location which the violation occurred, the owner may submit information to that effect by filling out an Affidavit of Non-Liability and mailing it prior to the Payment Due Date on the front of this Notice. Send your Affidavit of Non-Liability, the required supporting documentation, and a copy of this Notice of Violation to the City of Suffolk, PO Box 17007 Baltimore, MD 21297-0496. The Affidavit of Non-Liability form can be downloaded at www.onlinecitationpayment.com. You will need your Summons # and PIN printed on the front of this Notice.
- 3. AFFIDAVIT OF NON-OPERATION (Rental and Leasing Companies ONLY): Virginia State Code 15.2-968. 1 § D (i), provides the notified owner of a vehicle who was not the driver, the ability to file an Affidavit of Non-Operation, by regular mail affirming he/she was not the operator of the vehicle at the time of the alleged violation. The Affidavit of Non-Operation form downloaded at www.onlinecitationpayment.com. You will need your Summons # and PIN printed on the front of this Notice. Your Affidavit of Non-Operation must be received prior to the Payment Due Date on the front of this Notice. Send your Affidavit of Non-Operation, the required supporting documentation, and a copy of this Notice of Violation to the City of Suffolk, PO Box 17007 Baltimore, MD 21297-0496.

If you **DO NOT** intend on contesting this violation, you **DO NOT** need to appear in court.

VIEW YOUR IMAGES AND VIDEO: The recorded images and video will be submitted as evidence in the City of Suffolk Judicial Court proceeding for prosecution of the violation.
